

Specific Procurement Notice

Invitation to Quote for the Supply of Goods

FOR

OUTFITTING MEDICAL STATION & ISOLATION AREA

1. The government of Grenada has received a credit from the World Bank - International Development Association (IDA) for the Caribbean Air Transport Connectivity Project, and intends to apply part of the funds for the purchase of Goods (medical equipment to outfit the medical station & isolation area of the Grenada Airport Authority) for which this Invitation to Quote is issued.

Bidding competition will be conducted through Request for Quotation method as specified in the World Bank's "Procurement Regulations for IPF Borrowers" dated July 2016, Revised November 2017, August 2018 and November 2020 and is open to all eligible Suppliers as defined in the Procurement Regulation.

2. The goods are required to be supplied with a maximum of 90 days from the date of the contract signature.
3. Interested qualified eligible suppliers are invited to obtain a copy of the bidding documents at no charge from the address given below by submitting a written application/request. Except for the submission of a written application, there shall be no other conditions for obtaining the bidding documents. Bidding documents will be sent by e-mail only.
4. To be considered eligible and qualified a firm must:
 - a) Have authorization or dealership from the manufacturer to sell the goods
 - b) Have shops or offices to provide after sales services
 - c) Demonstrate that they are paying taxes to the Government.
 - d) Not be under any notice of suspension or debarment issued by the Government, or the World Bank.
5. Bids must be delivered to the address given below at or before **January 31, 2023, (15:00) hrs, local time**. Late bids will be rejected. Bids will be opened in public immediately thereafter at the address given below in the presence of the Bidders' representatives and the project's beneficiaries from the concerned local community who choose to attend shall be allowed to be present in person.
6. The Purchaser shall award the Contract to the Bidder whose offer has been determined to be

the lowest evaluated bid and is substantially responsive to the Bidding Documents, provided further that the Bidder is determined to be qualified to perform the Contract satisfactorily.

7. All bids must be accompanied by a bid securing declaration as described in the bidding documents; any bid not accompanied by one will be rejected as non-compliant

Bids should be submitted in sealed envelopes, with the name and address of the bidder, and be clearly marked "**PROCUREMENT OF GOODS - OUTFITTING MEDICAL STATION & ISOLATION AREA, Reference no GD-MOIID-298857-GO-RFQ**" and must be delivered to the address listed above. Bids will be opened publicly, immediately after the deadline for the submission of bids in the presence of Bidders' representatives who choose to attend.

In case of electronic submission, the Bids are required to be password protected, with the password submission 10 minutes before the schedule opening of the bids via the same email address.

The Government of Grenada and/or the World Bank will declare a firm ineligible either indefinitely or for a stated period of time to be awarded a contract financed by the Government of Grenada and/or the World Bank respectively, if it at any time determines that the firm has engaged in corrupt or fraudulent, coercive or collusive practices in competing for or in executing a contract.
