The *Government of Grenada* **has received** financing from the International Development Association (IDA) toward the cost of the *Digital Government for Resilience Project* and intends to apply part of the proceeds toward payments under the contract for *Procurement of Civil Registry Information Software*
2. The *Ministry of Finance Economic Development, Physical Development, Public Utilities & Energy* now invites sealed Bids from eligible Bidders for *the design, supply and installation, customization and enhancement of the Digital Civil Registry in Grenada.*

Bidding will be conducted through international competitive procurement using Request for Bids (RFB) as specified in the World Bank’s “Procurement Regulations for IPF Borrowers” World Bank’s *Procurement Regulations for IPF Borrowers*, July, 2016 (“Procurement Regulations”), and is open to all eligible Bidders as defined in the Procurement Regulations.

6. Bids must be delivered to the address below **January 20, 2023 on or before 2:00 p.m.** Electronic submission of Bids **will** be permitted. Late Bids will be rejected. Bids will be

publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below.

7. All Bids must be accompanied by a *Bid-Securing Declaration*.
8. **“Attention is drawn to the Procurement Regulations requiring the Borrower to disclose information on the successful bidder’s beneficial ownership, as part of the Contract Award Notice, using the Beneficial Ownership Disclosure Form as included in the bidding document.”**
