**INVITATION FOR BIDS – THE RENOVATION OF BELLEVUE MEDICAL STATION
ENVIRONMENT HEALTH AND VECTOR CONTROL FACILITY, ST DAVID**

The Government of Grenada intends to finance The Renovation of Bellevue Medical Station Environment Health and Vector Control Facility, St David. This project is geared towards the continuous improvement of health facilities to strengthen the public health system and emergency management. The Ministry of Infrastructure, Public Utilities, Civil Aviation and Transportation invites suitable contractors to participate in the tendering process

Firms whether applying individually or in the form of a Joint Venture, shall:

- (a) be legally incorporated or otherwise organized in, and have their principal place of business in an Eligible Country;
- (b) be more than fifty (50) percent beneficially owned dictating by a citizen or citizens and/or a bona fide resident or residents of an Eligible Country, or by a body corporate or bodies meeting these requirements, as far as the ownership can be reasonably determined; and
- (c) shall have no arrangement and undertake not to make any arrangement whereby the majority of the financial benefits of the contract, i.e. more than fifty (50) percent of the value of the contract, will accrue or be paid to sub-contractors or sub-consultants that are not from an Eligible Country.

Eligible countries are member States of CARICOM. Tenderers are advised to review the detailed eligibility criteria and conflict of interest provisions in the tender documents.

The requirements for qualification will include:

- (a) Experience as prime contractor in the construction of at least 5 assignments of a nature and complexity comparable to the proposed project activity within the last 3 years,
- (b) Demonstrable cash flow (including access to credit)
- (c) Key Personnel & Equipment
- (d) Tax Compliance Certificate

Interested eligible applicants may obtain a complete set of the Tender Documents in English at the Ministry of Infrastructure at the first address below hard copy , Monday to Friday from 8:00 a.m. to 4:00 p.m.

Tender submissions must be in English and must be submitted hard copy to the mailing address below on

June 5th , 2023, at 2:00 pm

Bidder must submit the project in a sealed envelope, which shall be clearly marked with the name of the project :

The Government of Grenada will not be bound to assign any reason for not selecting any applicant and will not defray costs incurred by applicants in the preparation and submission of the tender documents.
