## Invitation to tender for Street Cleaning Services

### Towns of Gouyave, Victoria, Sauteurs, Hillsborough and Grand Anse/Morne Rouge Commercial Area.

The Grenada Solid Waste Management Authority (GSWMA) hereby invite the submission of tenders for the provision of Street Cleaning Services in four towns and one commercial area.

- (1) **The of town Gouyave includes :** Along the western main road from the bridge that spans the Little River to lower Depradine Street; along lower Depradine Street from its intersection with the western main road to St. Peter's Street; along St. Peter's Street from its intersection with lower Depradine Street to the bridge that is located just past the residence of Alban Harrack; along Middle River from Hubble Bridge to its intersection to Mongo Road. Along the western main road (When traveling south) from the vicinity of the Gouyave medical complex entrance (ie. the entrance of Doctor Bell) to its intersection with upper Depradine Street; along upper Depradine Street from its intersection with the western mainroad to its intersection with Hillsvew Road; along Hillsvew Road from its intersection with Upper Depradine Street to its intersection with Ottleys Lane; along Ottley's Lane from its intersection with Hillsvew Road to its intersection with Victoria Street; along Victoria Street from its intersection with Ottley's Lane to its intersection with Langton Road; along Langton Road from its intersection with Victoria Street to the vicinity of the rear of Hillsvew Home. Along St. Benoit's Street and its byroads. Along the seafront from the mouth of the Little River to beyond the fisheries complex.
- (2) **The Town of Victoria Includes:** Along the major storm water drain that crosses the western main road in the vicinity of Maricaibo to its intersection with Cruickshank Road; along Cruickshank Road from its intersection with the said storm water drain to "Hero's Square"; along Cruickshank Road from "Hero's Square" to the former location of the large concrete solid waste receptacle that is located along the road that leads to Bonair; along the St. Mark's River from the vicinity of the said large concrete solid waste receptacle to the mouth of the St. Mark's River; along the seafront from the mouth of the St. Mark's River to the mouth of the major storm Water drain that crosses the western main road in the vicinity of Maricaibo.
- (3) **The Town of Hillsborough Includes:** Along Lauriston Road from the sea defense concrete wall to its intersection with Main Street and Brunswick Road; along Brunswick Road from its intersection with Main Street and Lauriston Road to its intersection with Fort Hill; along Fort Hill from its intersection with Brunswick to its intersection with Church Street and Second Avenue; along Second Avenue from its intersection with Church Street and Fort Hill to its

intersection with Maurice Street; along Maurice Street from its intersection with Second Avenue to its intersection with upper Main Street; along the main storm water drain that runs from the vicinity of the intersection with Maurice Street and upper Main Street to the Hillsborough seafront; along the seafront from the vicinity of the mouth of the said storm water drain to the sea defense wall at Lauriston.

- (4) **The town of Sauteurs includes:** Along the main street that leads to Sauteurs from La Fortune bridge to its intersection with Main Street; along Main Street to its intersection with High Street; along High Street from its intersection with Main Street to ‘Norris Lewis Shop’. Along Redhead Street from its intersection with High Street to its intersection with the major culvert bridge that crosses Redhead Street. Along the main road of Coconut Row in the vicinity of the old sugar cane works (mill) to Maho Bridge along the main road that leads to Mt. Craven; along “The Lagoon” (river) from Maho Bridge to the mouth of “The Lagoon” (river); along the seafront from the mouth of “The Lagoon” (river) to the mouth of the concrete major storm water drain that crosses Main Street.

- (5) **The Grand Anse/Morne Rough Commercial Area:** All of Grand Anse main road from the Fall Edge to Food Fair Intersection, Morne Toute main road to Sugar Mill intersection, Grand Anse Valley road up to Mt. Hartman Junction. Maurice Bishop Highway to True Blue round about and back down the highway. Republic Round about back to Grand Anse main road to Wall Street, Morne Rough loop back to Food Fair intersection.

Pre-tenders meeting will be held as follows:

- a. For Street Cleaning Services **Town of Hillsborough**, Carriacou on Tuesday 16<sup>th</sup> May 2023, 1:00pm at the Multi-Purpose Center, Hillsborough, Carriacou.
- b. For the towns of **Gouyave, Victoria and, Sauteurs and the Grand Anse/Morne Rough Commercial area** on Thursday 18<sup>th</sup> May 2023, 1:00pm at the Grenada National Stadium Player Level 1 Conference Room (Ground Floor Cricket Stadium) Ground Floor.

All interested parties are invited to attend.

Tender documents would be available for sale from Monday 22<sup>nd</sup> May 2023 for a non-refundable fee of EC\$200.00.

The deadline date for the receipt of complete tenders is Friday 23<sup>rd</sup> June 2023 at 2:00pm.

Submissions must be made in sealed envelopes, clearly marked as follows:

Each Successful company shall be expected to enter into a contractual agreement with the GSWMA for the provision of street cleaning services in the applicable town. The responsibilities of the successful tenderer shall include but not limited to the provision of labour and equipment to accomplish the following among others:

1. The Provision of Street cleaning, drain cleaning and seafront cleaning services to all streets, drains, alleyways and allowed byways within the specified towns and Commercial area.
2. The regular de-bushing of all drains, verges and alleyways within the specified towns
3. The transportation and delivery of all solid waste including street sweepings and drain deposits resulting from the cleaning of the towns, to the GSWMA's Authorised disposal facilities;
4. The collecting and depositing of all dead animals from the streets, drains, alleyways and byways within the specified town boundary.
